# Liquid Waste Transporters Operating Permit Application - Submittal Instructions

Pursuant to the provisions of Sections 24-18 and 24-46, Miami-Dade County Code, an operating permit is required for any person (e.g., individual, company, corporation, partnership, governmental agency, etc.) intending to cause the transportation of liquid waste in Miami-Dade County. For the purpose of this application form, "liquid waste" and "transportation of liquid waste" have the following meaning:

<u>Liquid Waste</u> means liquid or sludge waste materials resulting from domestic, commercial, industrial, mining, institutional, agricultural, or governmental operations, including such materials to be recycled or otherwise beneficially reused, that would cause a nuisance or would otherwise cause a violation of Chapter 24, Miami-Dade County Code, if discharged to the ground or waters of Miami-Dade County. Liquid waste includes, but is not limited to, solvents, sewage, industrial waste, hazardous waste, semisolid waste, and potentially infectious waste (e.g., biohazardous waste, etc.), as well as the materials resulting from or contained in waste treatment works, air pollution control facilities, on-site sewage treatment and disposal systems, fats, oils and grease control devices (grease interceptors), sediment traps, portable toilets and oil-water separators.

Transportation of Liquid Waste means the transportation of liquid waste that originates or ends within the geographical boundaries of Miami-Dade County.

Note: The transportation of solid waste or recyclable materials (e.g., garbage, trash, yard waste, waste tires, etc.) in Miami-Dade County is regulated by the Miami-Dade Department of Solid Waste Management (DSWM).

#### Permit Application Types - When is the submittal of a Liquid Waste Transporters operating permit application required?

A permit application form is required to be completed and submitted to the Department of Regulatory and Economic Resources, Division of Environmental Resources Management (DERM), in the following scenarios:

New permits: Applies to all new transporters seeking to operate in Miami-Dade County, legal name changes of existing permittees (including modifications/additions of fictitious names), and additions of new waste categories.

Permit renewals: All permitted transporters are required to submit a complete application to renew their annual operating permit. Permit renewal notices are sent to all permitted approximately 60 days prior to permit expiration.

Permit modifications: Applies to modifications of existing permits which are limited to updates to business contact information, vehicle storage locations, and vehicle inventory only.

### **Application Submittal and Payment Instructions**

Complete permit applications, inclusive of the applicable fee, are to be submitted to DERM via one of the following methods:

Fees for Liquid Waste Transporters permit applications are as follows:

New permits: \$215.00 (per application) Permit renewals: \$107.50 (permit permit, per cycle) Permit modifications: no charge

#### Acceptable payment methods:

For applications submitted in person: credit card, check or money order.

For applications submitted via email: Upon receipt and processing of the application, DERM staff will send an email to the applicant that includes an invoice process number, link to submit payment online, and associated payment instructions. Online payments can be made with a credit card or bank account.

For applications submitted by mail: check or money order made payable to "Miami-Dade County" (reference applicant's name on all checks).

#### Compliance with Operating Permit Requirements - Transporter Responsibilities

Liquid waste transporters (LWT) program operating permits are issued annually by DERM on a waste-class basis that include operating conditions that transporters must abide by and which are specific to the class of waste authorized to be transported. The current listing of waste classes can be found in section B of the LWT operating permit application form.

#### **Vehicle Inventory Updates (applies to all transporters)**

Transporters are required to maintain a current registration with DERM of all vehicles used to transport liquid waste in Miami-Dade County. Changes to vehicle inventory (i.e., additions and/or removal of vehicles) are required to be submitted to DERM as they occur and as part of a permit modification application.

#### **Vehicle Decals (applies to all transporters)**

Transport vehicles registered with DERM are required to bear a current DERM-issued Liquid Waste Transporters program decal at all times. Decals are issued to all tractors and single-unit vehicles (e.g., vac-trucks, etc.) registered for each class of waste that the transporter is permitted to transport. For example, if a single tractor is registered under two waste classes, DERM will issue 2 decals to said vehicle.

#### Monthly Reporting (applies to all transporters)

All liquid waste transporters are required to submit a monthly report on DERM-approved reporting forms that document all transportation activities originating or ending in Miami-Dade County and which are completed between the first and last day of each calendar month. Monthly reports require haulers to provide information such as the location of the waste origination and destination sites, description of waste transported, and quantity transported. The submittal of monthly reports is also required for months where no transportation activities occurred. All completed monthly report forms must be submitted to DERM in accordance with the requirements and timeframes specified in the conditions of the DERM-issued permit and include payment of the applicable operating permit fees based on the type of waste and total quantity of waste transported. For a listing of the operating fee rates applicable to hauled waste please refer to the "Hazardous Materials Storage and Transportation" section of the latest DERM fee schedule (https://www.miamidade.gov/permits/library/fees/schedule-environmental.pdf).

#### e-Manifest Reporting (applies to "ST" waste class permit holders only)

In addition to the monthly reporting requirement discussed above, transporters permitted under the "ST" waste class which includes septage, grease interceptor waste (fats, oil and grease) and uncontaminated stormwater are required to document all waste transportation activities on DERM-approved eManifest forms and electronically report the information using DERM's online eManifest system. #### Disposal at plants operated by MDWASD (applies applies to "ST" waste class permit holders only)

Disposal of liquid waste at treatment plants operated by the Miami-Dade Water & Sewer Department (MDWASD) is limited to fats, oil and grease (FOG) waste, septage, portable toilet waste (not containing formaling or formaldehyde-based disinfectants) and uncontaminated stormwater. Transporters seeking to dispose of these wastes at MDWASD plants must possess a "ST" waste class liquid waste transporters permit issued by DERM and a MDWASD septage disposal account. #### Dewatering activities associated with stormwater management system maintenance

Dewatering activities associated with maintenance of stormwater management systems (public or private) located in Miami-Dade County must not be conducted without a valid a Class V Dewatering permit issued by the Water Control Section of DERM. A Class V permit for such activities must be obtained by the system owner or the entity providing the service. These dewatering activities must be conducted in accordance with best management practices (BMPs) established by the Water Control Section. The transportation of liquid materials (resulting from stormwater management system maintenance activities) outside of the boundaries of the system being serviced (private or utility system) is subject to the requirements of the DERM Liquid Waste Transporters (LWT) program and must not be conducted without a valid LWT program operating permit issued by DERM.
